Briefing

This publication provides an analysis of the results of the CPI for August 2019 with the base year 2014. In addition, it provides the results of CPI by household welfare levels, by household type, by Abu Dhabi regions and provides the percentage contribution of the major expenditure groups in the annual price change.

Key Points

- The consumer price index decreased by 0.8% during the period January-August of 2019 compared with the same period of 2018, the index reached 111.1% for the period January-August of 2019, while it was 111.9% for the same period of 2018.
- The CPI decreased by 1.2% in August 2019 compared with August 2018, where the index reached 110.8% during August 2019, while it was 112.1% in August 2018.
- The CPI increased by 0.4% in August 2019 compared with July 2019, where the index reached 110.8% during August 2019, while it was 110.4% in July 2019.
- The decline in consumer prices during the period Jan-August 2019 compared with the same period of 2018, contributed to a decrease of 1.2% in consumer prices for households of the bottom welfare level, and 1.0% for the middle welfare level, and 0.4% for the top welfare level.
- The decline in consumer prices during the period Jan-August of 2019 compared with the same period of 2018, contributed to a decrease of 0.8% for citizen households and non-citizen households, and 1.3% for shared households.
- The "Housing, water, electricity, gas and fuel" group contributed 151.8% to the overall decrease in the CPI during the period Jan-August of 2019 compared with the same period of 2018. Prices of this group decreased by 3.6% over the same period.
- Prices of the 'Transport' group decreased by 6.0% during the period Jan-August of 2019 compared with the same period of 2018, and contributed 119.5% to the overall decrease.
- The 'Food and beverages' group contributed by 33.2% to the overall decrease in the CPI during the period Jan-August of 2019 compared with the same period of 2018. Prices of this group decreased by 2.1% over the same period.
- Prices of the 'Recreation and culture' group increased by 19.8% during the period Jan-August 2019 compared with the same period of 2018, and contributed 119.7% in reducing the overall decrease in the CPI.




Figure (1): Annual inflation rates for the months of 2017 - 2019




Figure (2): CPI for the months of 2017-2019

Data are obtained through a field survey by collecting the prices from different outlets in Abu Dhabi Regions (Abu Dhabi, Al Ain and Al Dhafra) The data are processed and passed to the Prices and Income Section at Statistic Centre – Abu Dhabi for further editing and compilation.

The CPI is compiled on a monthly basis, within 12 working days from the end of the reference month. The results of CPI calculations are considered final. Therefore, the CPI figures are not subjected to future revisions because of new data becoming available. When an error is discovered, there are transparent procedures taken with a request sent to the Project Management Office to correct the error. These procedures are in line with the policy of the Statistics Center - Abu Dhabi. The base year of the Consumer Price Index is updated as recent data from the Household Income and Expenditure Survey (HIES) become available, usually updated every five years.
